Clients Helping Clients

Four years ago Mary and her two sons came to Shepherd's Crossing for assistance. Mary needed help because she was paying so much out of her earnings for childcare that she was falling behind financially each month. She worked evenings so she needed childcare from soon after school to midnight. At that same time, Jack, a former soldier whose wife had left the home, came to the Crossing for assistance. He was planning to attend K-State that fall, but was falling short of being able to handle bills and childcare for his three-year old daughter on his school military assistance. Mary's sons, ages nine and six were at the children's play area when Jack's daughter joined them. The older of the two boys was drawn to helping the little girl find toys for herself. She responded to him in a very positive way. They were soon playing together contentedly. A few days later Jack and his daughter were leaving their apartment building for a walk when Jack's daughter spotted Mary's boys playing in the yard of the second house down from her home. The older boy again engaged the little girl in play while the parents introduced themselves and watched their children playing. During that conversation Mary mentioned her problem with finding and paying for childcare. Very soon Jack and Mary realized that maybe they could help each other.

Sharing with the Shepherd

The funds went into our general fund, enabling us to provide rent and utility assistance to approximately 180 more low-income families in Manhattan and Riley County because of your generosity. She needed childcare after school to midnight. Jack needed childcare for his daughter during the day, but was home in the evenings. Since that time Mary and Jack have continued to share responsibility for the other's children while the other attended classes or worked. Both have gotten assistance from Shepherd's Crossing three or four times since that August meeting, but caring for the other's children has greatly decreased the need for very expensive childcare. Jack will soon complete his degree. Mary has been able to have funds to take some online classes, which will enable her to secure a better paying job. What a joy to know that Shepherd's Crossing was the catalyst leading to this solution.

Message from the Executive Director

February 6 was our day of LIEAP assistance. LIEAP means **L**ow **I**ncome **E**nergy **A**ssistance **P**rogram. LIEAP is a federally funded program to help low-income households pay a portion of their home energy costs. They must complete a multi-page application with many details, so Westar Energy sent over a representative from 10 a.m. to 4 p.m. to oversee their paperwork. She assisted 27 households and 10 others took the application home with them.

One older man was overwhelmed with the many details, so our staff person directed him to the table with the applications and told him to fill out the information that he knew. He kept asking if he was doing it correctly. When it was his turn to meet with the Westar representative, she looked over his application, asked him a few more questions and told him it was ready to be signed and mailed. He asked, "Is that all?" What a joy that we can be of assistance in other ways! —*Beverly Olson, Executive Director*
